MESSAGE FROM THE CEO

Groundwork Jacksonville is all about action and that has never been more evident than right now. In just three years since the Jacksonville City Council adopted Groundwork's Emerald Trail Master Plan, we have two projects under construction—the LaVilla Link and McCoys Creek—and Hogan Street (segment 2) and Hogans Creek are in design.

This progress would not be possible without our partner—the City of Jacksonville (COJ), the commitment of Mayor Lenny Curry and the Jacksonville City Council, and the support of the COJ public works and parks departments. It also would not be possible without the generous support of our visionary donors and incredible partners. Thank you for whole-heartedly embracing the notion that Jacksonville deserves a world-class trail system and vibrant urban core.

I am grateful to our staff who work tirelessly to achieve our vision. They balance myriad projects and big expectations, while keeping our mission, and the needs and priorities of our stakeholders at the center of everything we do.

And there is much work to be done. In addition to leading the Emerald Trail and urban creek restoration projects, we are working with partners to develop an affordable housing and economic opportunity strategy to help ensure long-term residents benefit from the opportunities the Emerald Trail will create.

As part of that strategy, we have established a home repair program in North Riverside, with plans to expand to other Emerald Trail neighborhoods. In addition, early next year we will launch the Emerald Trail Stewards program to hire and train residents from our urban neighborhoods in skilled landscaping and trail maintenance. We believe this will be a win-win; both for the community who expects a well-maintained trail, and for the residents who will be paid stewards.

The Emerald Trail is a dynamic example of the power of public-private partnerships. While almost 90 percent of the trail will be publicly funded—including \$132M over the next 30 years from the Local Option Gas Tax—private investment ensures the project is, and remains, a community imperative.

In addition to strengthening our urban neighborhoods, your generous donations help Groundwork accelerate trail completion, protect the integrity of design and fund trail enhancements, green infrastructure, and ongoing maintenance.

I am pleased to share the 2020-2022 Annual Report highlighting the transformative work that your support helps to make possible.

In fact, FDEP Secretary Shawn Hamilton, a group from NPS and the State of Florida Chief Resilience Officer Wesley Brooks have all toured the project to see our work firsthand.

In June, Gloria McNair, our Manager of Community Engagement & Equity, presented at the Urban Waters Learning Network (UWLN) national conference and is one of five members of the UWLN Equitable Development and Anti-Displacement Collaborative. Her work with North Riverside residents to create an equitable development plan was also highlighted in a recent EPA brochure on equitable development.

Other recognition includes the Environmental Defense Fund "Keeping Florida, Florida" video series highlighting Jacksonville. We also earned the Award of Excellence for Environmental Stewardship from the Northeast Florida Regional Council.

These examples illustrate the level of professionalism and personal commitment this team brings to their work and the impact they are making in our world. We can all be very proud to support Groundwork Jacksonville. I know that I am.

OUR WORK

Groundwork Jacksonville, Inc. (Groundwork) was founded locally in 2014 as a partnership between the City of Jacksonville, the US National Park Service, the US Environmental Protection Agency and Groundwork USA. Groundwork is one of 21 Trusts across the country, the only Trust in Florida and the first in the southeastern United States.

As the community's primary nonprofit organization focused on the environmental and economic renewal of Jacksonville's urban core neighborhoods, Groundwork is bringing together the expertise, resources and partners to transform the city center into a vibrant and connected destination for residents, businesses and tourists alike.

LAVILLA LINK

EMERALD TRAIL

Construction is well underway with much of the 14-foot wide trail already complete. Shade trees, native plants, lighting and benches will be added soon.

Trail features include the LaVilla Pond boardwalk and overlook funded by the David C. Miller Fund; Park Street bridge overlook funded by a challenge grant from the Delores Barr Weaver Fund at the Community Foundation for Northeast Florida; and the butterfly garden, along W. Church Street just east of I-95, funded by the Late Bloomers Garden Club.

EMERALD TRAIL

Design of the Hogan Street Link is underway and construction will begin in 2023. This .9-mile trail segment links the St. Johns River to FSCJ and Springfield through the urban core.

Groundwork and design firm Pond are working with developers and Hogan Street business owners to ensure the trail fits their retail and business needs.

MCCOYS CREEK

CREEK RESTORATION

Over the last two years, significant progress has been made along McCoys Creek. Flood-prone McCoys Creek Boulevard from Cherokee Street to Margaret Street has been removed permanently and new cul-de-sacs have been constructed at the end of several residential streets. These park-like areas are designed as residential living rooms encouraging neighbors to gather and enjoy the restored creek views.

Restoration of a section of the McCoys Creek channel (west of I-95) will begin by the end of the year along with the construction of higher, wider bridges at King Street and Stockton Street. The bridges will include bicycle/pedestrian lanes.

Broward Pond - Typical retention pond has been redeveloped with a living shoreline to create a park setting.



MCCOYS CREEK

CREEK RESTORATION

Groundwork and design firm WSP have completed the design for the one-mile McCoys Creek Branches, the creek's headwaters at the western edge of the creek. The design was funded, in part, by the National Fish and Wildlife Foundation (NFWF,) private foundations and individual donors. Groundwork has grant applications pending to fund construction.

Jacksonville University is partnering with Groundwork on a fish study to measure how the creek restoration improves fish population. Dr. Quinton White, executive director of the Jacksonville University Marine Science Research Institute and Dr. Daniel McCarthy, professor of biology and director of the MSC undergraduate program, enlisted the help of marine biology students to collect samples from the creek bottom (benthic) and submerged aquatic vegetation.



HOGANS CREEK

CREEK RESTORATION

Hogans Creek is listed as the #2 priority in the COJ's Local Mitigation Strategy—right behind McCoys Creek—and identified as high risk for flooding and storm surge.

Like McCoys Creek, Hogans Creek suffers from years of pollution, failing infrastructure and development that has encroached on its natural flood plain.

Through a \$294,000 grant from NFWF with support from NOAA and AT&T, \$100,000 from Jacksonville Environmental Protection Board and \$142,500 from a private donor, Groundwork has begun the preliminary Hogans Creek design. Groundwork is seeking additional funding from private donors and grantors to complete the \$5.9M design project.



Environmental design firm Halff is partnering with Ecosystems Planning & Restoration (EPR), Alpha Envirotech Consulting, and Ghiotto & Associates on the project.

Groundwork has actively engaged residents of Springfield, Historic Eastside and the Cathedral District in Task Force meetings, creek walks, public meetings and the Hogans Creek Fest to garner community input that is being incorporated into the preliminary design.



STEWARDSHIP GREEN TEAM

GOAL: Prepare Jacksonville's youth for a lifetime of environmental and community leadership

Green Team Youth Corps encourages teens to play, learn, serve and work year-round. Each summer 20-22 teens participate in the nine-week apprenticeship program for which they earn a stipend as well as community service hours. During the school year, 10-12 teens are selected as Green Team Fellows and meet each Saturday for a variety of learning and service opportunities.

The teens are introduced to science, technology, engineering, arts and math (STEAM) concepts and gain skills in environmental conservation, leadership, planning and public speaking. But they also have fun! Activities such as fishing, kayaking, beach days and floating down the Ichetucknee River offer plenty of opportunities for the teens to laugh, connect and form life-long friendships.

Over the last two years, the teens have completed trail maintenance along the S-Line Rail Trail including planting a living shoreline to improve the beauty and habitat of the S-Line Pond. They planted a pollinator garden at Jacksonville Arts & Music School (JAMS) and planned a fruit orchard that was installed in a neighborhood garden. In addition, the Green Team rolled up their sleeves to help plan and host Groundwork's Annual Earth Day Celebration.

One of the most exciting projects was building and deploying Pervious Oyster Shell Habitat (POSH) modules in partnership with the University of North Florida, National Park Service, National Park Foundation and funder, Stericycle. The ongoing effort aims to protect eroding shorelines at Timucuan Ecological and Historic Preserve as well as vulnerable wetlands across the National Park Service.

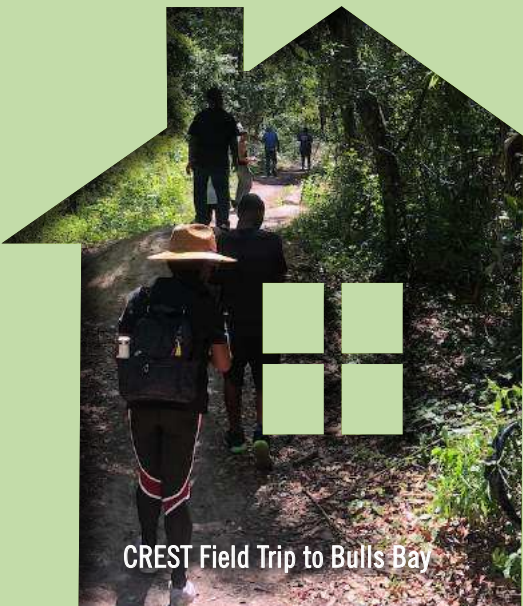

CREST STEWARDSHIP

GOAL: Encourage residents to be environmental stewards of their neighborhood

Community Restoration Environmental Stewardship Training (CREST) was developed in response to residents' desire to improve their neighborhoods and increase economic opportunities in their local community.

The program trains residents to be environmental stewards with workshops, community clean-ups and field trips. Workforce development is another important aspect of the program, offering training and job opportunities to CREST stewards. The inter-generational program is funded, in part, by a grant from Wells Fargo.

ENGAGEMENT & EQUITY

GOAL: Empower residents to affect change in their community
Develop partnerships and bring resources and training to urban neighborhoods
Minimize displacement

Equitable and inclusive community engagement is at the forefront of Groundwork programs. We regard community members as partners and a vital source of knowledge and experience. We work to ensure everyone has a seat at the table, a voice in defining the vision for their neighborhood and a role in co-producing decisions for equitable development.

This approach is evidenced in our work with residents of North Riverside. Prior to beginning the McCoys Creek restoration design, Groundwork began meeting with residents, both formally and informally, to understand their hopes and dreams for their neighborhood and how the restoration of McCoys Creek can support that vision. Many residents were disillusioned by years of unfulfilled promises. They had seen the neighborhood fall into disrepair, McCoys Creek become polluted and overgrown, and their parks taken away to build retention ponds that didn't solve persistent flooding problems.

Working hand-in-hand with the North Riverside Community Development Corporation (CDC), Groundwork facilitated a resident-led effort that resulted in a 10-year vision for the community, focusing on economic opportunities, housing, history & culture and environmental stewardship.

Four resident-led sub-committees were formed to address each of the concerns. Based on the committees' recommendations, the North Riverside Equity Action Plan was created

to work on each of these areas with emphasis on housing both as the primary means to build generational wealth and as the most effective defense against displacement.

As a result, Groundwork and the North Riverside CDC are partnering with LISC Jacksonville on a home repair program that is funded, in part, by a grant from the Edna Sproull Williams Foundation.

In addition, Groundwork will be engaging residents of 10 urban neighborhoods to create an ecologically based watershed restoration and management plan for the McCoys Creek and Hogans Creek watersheds. The goal is to identify specific remedies to reduce flooding, improve water quality, increase community resilience, restore habitat, and improve access to recreation.

Groundwork hopes that another outcome will be increased community knowledge about resilience and healthy watersheds, and the recruitment of community stewards and partners to install green infrastructure. The watershed project is funded through a grant from the Florida Department of Economic Opportunity's (DEO) Rebuild Florida General Planning Support Program. Groundwork hopes the plan will be a model the City of Jacksonville can replicate throughout other regional watersheds.

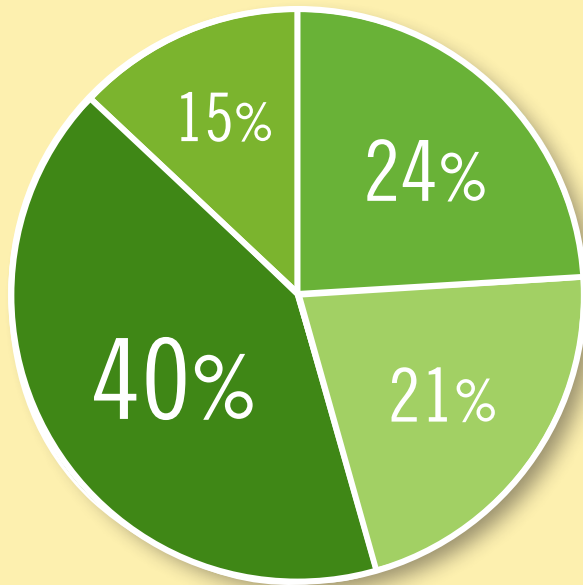

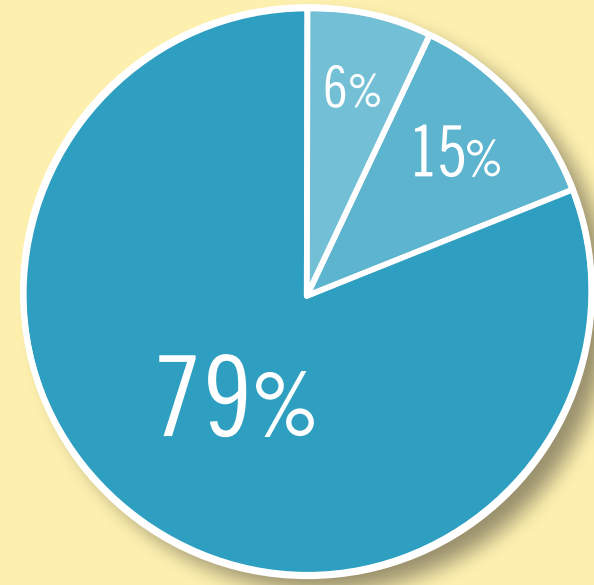

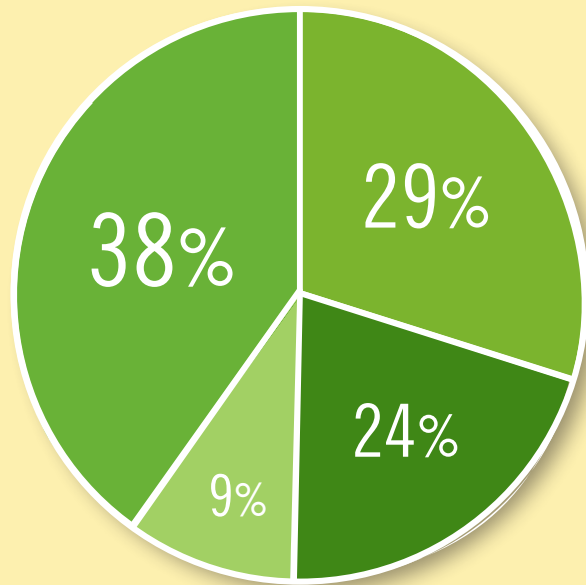

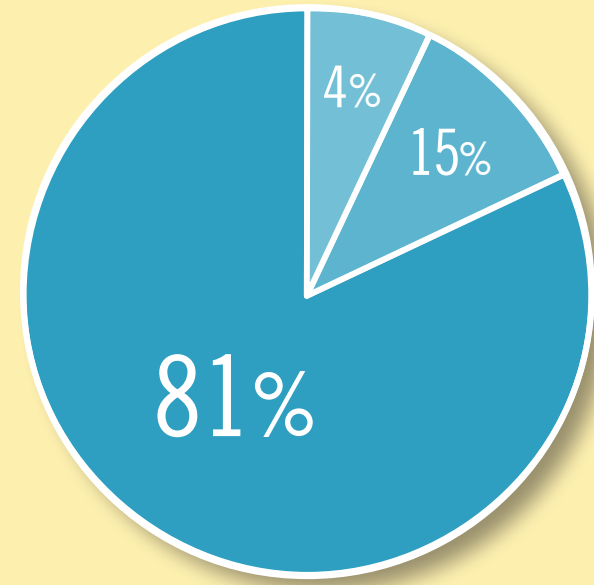
